Title: Reflections on my fieldwork

Description: .A field report reflecting on the theology of chaplaincy in the context of the student's chaplaincy placement. Students must evaluate the theology at play in the chaplaincy context; the various approaches employed, ways to enhance the chaplaincy praxis and the effectiveness of the chaplaincy process.

This can be in the form of topic Reviews and does not need to include any academic references.

Or it can be in the form of an academic essay and will include 10- 15 academic references.
